Turnout for the meeting was better than expected and those that came brought many ideas and participated in the discussion. We started with a list of what we currently do and generated a list of ideas on additional projects we might consider. The end goal is to be recognized as an organization that truly makes a positive influence in our community.

Current Community Involvement:

Support for Veterans including the Annual Veterans lunch at the Lodge, supplying and cooking a lunch at the Reno Veterans Hospital twice a year, participation in the Auburn Veterans Day Parade, and gift card donations to the Placer County Veterans Service Office to be distributed to homeless Veterans in our area.

Financial Donations to 5 local High Schools for Grad Night activities

Public Safety Awards Dinner

Participation in Hoop Shoot and Soccer shoot-out

Coat Drive, Canned Food Drives, Toys for Tots

Donation of School Supplies to Placer School District

Use of Lodge to Boy Scouts and Girl Scouts

Financial Donation to Auburn Festival of Lights Parade and providing the float that Santa rides on each year Donations to Wreaths Across America

Purple Pig Donations (California Hawaii State Major Project)

ENF Donations (Donations to Elks National Foundation are necessary to participate in and receive grants from ENF that can then be used to support local projects)

Other areas where we have been involved in the recent past:

ENF Grants have been used to support the Auburn Boys and Girls Club, Auburn Police Department, Gathering Inn, etc.

Fashion Show and Fundraiser

Volunteers helped with Placer High School Grad night

Suggestions that were made for other projects where we could be involved:

Helping at Senior Facilities, Contact Auburn Senior Center for needs

Assist sports programs at Placer High School

Walk a thon type fundraiser

Organize or participate in community events such as trash clean-up day, assisting at food banks, health fairs, blood drives

Assist Elementary Schools as needed - tutoring

Sponsor a Little League team

Develop programs to support senior citizens (transportation, tasks)

Expand our canned food, coats, and toy donations to include a drive-by event for collections

Sutter Health Hospital - any needs we can support

Contact other community service groups to see how we can be of service (Salvation Army, Gathering Inn, etc.) Contact all Veterans groups (American Legion, VFW, Vietnam Veterans Association, Auburn Navy League to determine how Auburn - Grass Valley Elks can be of service

In addition to projects a good deal of time was spent discussing how we can make ourselves more visible in the community:

Regular attendance at the Auburn Chamber of Commerce.

Bingo for the public.

Open Easter Egg hunt to the public.

Set our pop-up as a booth at as many public functions as we can such as Auburn Cruise Night, Farmers Market, Gold Country Fair, Auburn Air Show, and 4th of July celebration.

Advertise on local radio and in Auburn Journal - both provide free airtime to post on upcoming events.

Take photos and write articles on events we participate in to be submitted to local paper and Elks state and National publications.

Provide speakers to other organizations such as SIR, Rotary, Chamber of Commerce, etc. summarizing who Elks are and what we do.

And for our Lodge consider some type of calling tree to contact all members over time regarding activities at the Lodge.

This is not a complete list of all items discussed but is meant to give you an idea of what type of projects we could pursue. Most of these would require additional volunteers but I have a personal feeling that people might be more willing to volunteer for a specific project supporting the community rather than serving or clearing tables at the Lodge. Not that both are not very much needed for us to be successful. On February 28th we will have another session to identify what items we should focus our efforts on. These are great ideas, but we can't do it all. I suggest we pick a couple of items and do them well to start with.

Also. one final note is that a good deal of this list is geared towards Auburn. We recognize that we are now Auburn - Grass Valley Lodge and need to look for opportunities in Grass Valley and places in between as well.


